On careful consideration of the proposal, the Government of Karnataka has decided to issue a Renewal No Objection Certificate to start for the same 60 seats in BHMS Degree Course for the year 2019-20.

It is certified that:-

- a) Based on the reports permission for starting of new Homoeopathic Medical College, by the S.V.E. Trust's ® Humnabad, Hence the permission may be granted for the year 2019-20.
- b) It is desirable & feasible to establish an Homoeopathic College imparting a BHMS Degree course with an Intake Capacity of 60 seats.

It is also certified that adequate infrastructure and material as per norms of the Central Council of Indian Medicine are available with the proposed Medical College. It is further certified that in case the applicant fails to create infrastructure for the Ayurveda College as per Central Council of Indian Medicine norms and fresh admissions are stopped by the Central Council /Central Government, the State Government shall take over the responsibility of the students already admitted in the college with the permission of the Central Government.


