This has reference to your representation dated 06/12/2021 & 27/12/2021 to Commission against the permission letter passed by vide letter F.No.4-7/2021-22/NCH (MA&RB))116-11)/3394 dated 29/11/2021. The submission made through representation dated 20/10/2021 to consider the required documents/information pointed out while issuing denial of permission for continuing admissions with student intake of 60 seats for 1- BHMS course for the academic session 2021-22 vide letter F.No.4-7/2021-22/NCH (MA&RB))116-11)/3394 dated 29/11/2021 has been carefully examined by the Commission and observed the following:

1. Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 29/11/2021 mentioned , that Hospital Staff- Surgeon & Obstetrician/ Gynaecologist mentioned as on call against full time. Relevant documents for Dr Savitri J Karigar, Dept. of Surgery and Dr Padma Salimath, Dept. of OBG (both as Full time) not provided by the College

Surgeon and Gynecologist are working as full time staff. Dr Savitri J Karigar is working as Surgery professor since 29/03/2021. She is working in the Hospital as full time staff. Dr Padma Salimath is working in OBG Department since 01/01/2021. Appointment letter, joining letter, salary statement, attendance, qualification and experience letter were enclosed. While uploading Part-1 Dr Amar Erolkar name was uploaded due to oversight. Dr Amar Erolkar was appointed as guest faculty of Surgery since 16/04/2020.

Observation:

Commission examined the documents and observed that the College is having 02 new regular staff in Surgery and Gynecology Departments. These appointments were made (01/03/2021) before virtual Hearing. Appointments are endorsed by the Principal of the college. The deficiency is not existing.

2. Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 29/11/2021 mentioned thatYoga Expert and Physiotherapist: College informed that Mr. Nagarndra Shankar Yoga Expert joined on 02/11/2017 & Physiotherapist: Dr. Romeshchandra Matti, Physiotherapist is Page 1 of 5 working since 01/11/2017. Both are on call. Relevant documents are not provided by the

Yoga expert Mr. Nagarndra Shankar is appointed and working since 02/11/2017. Physiotherapist: Dr. Romeshchandra Matti is working since 01/11/2017. The same was shown in Part-1 of Hospital Staff list and also shown in the Hospital details from. The necessary documents of appointment letter, joining letter, salary statement, attendance, qualification and experience **Observation**:

Documents such as appointment letter (dated 23/10/2017) joining letter (dated 02/11/2017) for Yoga Expert and Physiotherapist appointment letter (dated 01/11/2017) joining letter(dated 07/11/2017) submitted. Form 16 for these staffs submitted. Hence, the point is not existing.

3. Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 29/11/2021 mentioned thatHospital Equipment-Stretcher with trolley 02 against 04 Diagnostic set (ENT) 02 against 04 College could not produce relevant documents related to this

Stock registers and purchase bills for 04 ENT Diagnostic sets Submitted. Due to typographical error we are unable to upload Part1.

Observation:

Commission observed that the necessary documents to substantiate the presence of Hospital Equipments were not available as per regulation (4) of Regulation 10 of MSR-2013. Moreover, the invoice dated 06/04/2021 for stretcher trolley and ENT Kit & entries were made on stock register were not shown during Virtual Hearing. Stock register entries were done after 11/08/2021 with the date 06/04/2021. New documents submitted after virtual hearing held on 29/10/2021 is not acceptable. Hence the deficiency persists.

4. Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 29/11/2021 mentioned that Part Time Teachers (09) - Total available-04, College could not provide relevant documents w r t college part time teachers. Thus deficiencies persist

Due to lack of Knowledge typographical error was made by system operator, actual available part time teachers are 09, staff list Supporting documents for the following staff submitted: Dr Akash Andagi, Physician MBBS, MD(GM); Dr Padma Salimath, OBG, MBBS, DGO; Dr Shashidhar M Thumaba Dentist BDS; Dr Nagath Hulsure, Surgeon, MBBS, MS; Dr Sharanappa Halidoddi, Radiologist MBBS. DMRD; Dr Sujata Harkood, Aneasthsia MBBS DA; Dr Veerendra A.Patil, Pathologist, MBBS MD (Patho); Dr Sangamesh Slegoun, Pediatrician MBBS DCH &Dr Chandrakanth, Opthalomolgist MBBS, DOMS

Observation:

Commission examined the documents related to 09 Part Time teachers. The appointment letter & joining letter for the staff verified. Even though document for one Part time teacher was not available, Form 16 for these staffs was submitted. Hence the point does not exist.

5. Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 29/11/2021 mentioned that leaching Departments-Anatomy -Provisions of Anatomy Act mentioned as 'applied'

This institute applied for recognition under Anatomy Act on 10/12/20219 and reminder were also sent on 15/04/2021 to get it. That was in process and shortly we will get registration and submit accordingly.

Committee observed that the College, though being an old Collage but not covered under the provisions of Anatomy Act. Hence the point exists.

6. Submission of College to Commission:

Observations of Hearing Committee & M4&RB vide letter dated 29/11/2021 mentioned that College laboratories: Anatomy,-Microscope (Medical) ()5 against 25 Homoeopathic Pharmacy- Pyknometer (Specific Gravity Bottle) 01 against 02. Animal Specimens not available, Physiology& Biochemistry-Balance chemical/ordinary 01 against 02.

Copy of purchase bills dated 11.08.2016 for equipment. Stock register, bill dated 11.08 2016 for Pyknometer (Specific Gravity Bottle) 02 against 02; cash bill for purchase of animal specimen dated 14/10/2019; Balance, chemical/ordinary 02 against 02

Observation:

Copy of purchase bills dated 11.08.2016 showing availability of 25 equipment, Stock register showing entry of 05 microscopes, bill dated 11.08.2016 for Pyknometer (Specific Gravity Bottle) 02 against 02,cash bill for purchase of animal specimen for starfish, cockroach and NajaNaja model dated 14/10/2019, Stock register showing balance. (chemical/ordinary) 02 against 02 is available with the College. Commission examined these documents and opined that the College is having equipment/facilities for the laboratories in the College as per MSR, 2013. Hence · deficiency does not exist.

7. Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 29/11/2021 mentioned that Library - Only one library assistant is available against requirement of 02

This institution has 02 Library assistants. Mr Sanjeev Kumar was appointed on 01/08/2021 and working. Documents of appointment order, joining letter, attendance register, ID card submitted. Appointment letter & joining letter dated 01/08/2021 attendance register for October 2021 for Mr Sanjeev Kumar is submitted.

Observation:

These documents were not submitted to hearing Committee. Hence the deficiency persists.

8. Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 29/11/2021 mentioned that Miscellaneous – EPF/PF (ESI deductions of teachers, non-teaching staff & hospital staff– Not provided. Form-16 of teachers, non teaching staff & hospital staff- Not provided

Registered copies & payment slips submitted

Observation:

Commission examined the copies of Challan generated on 30/10/2021 for EPF/PF /ESI deductions of teachers, non teaching staff & hospital staff. Form 16 (total 44) for teachers (01/04/2021 to 30/11/02021), non - teaching staff & hospital staff submitted by the College. Committee observed that the College has submitted the documents to substantiate the genuinity of staff available in the college. Hence the deficiency does not exist.

9. Submission of College to Commission:

Observations of Hearing Committee & MA&RB vide letter dated 29.11-2021 mentioned tails of high-states in Full that details of Ineligible Teachers College has given explanation regarding discrepancy in Full Time as well as College has given explanation regarding discrepancy in Full Time as well as Guest Teachers but relevant documents such as experience letter, affidavit or reannointmost later. reappointment letter not provided. Therefore deficiencies persist

College submitted all necessary supporting documents for the Lull Time as well as Guest Teachers in Department of Anatomy, Physiology, Organon of medicine, Pharmacy Materia Medica Pathology, Department of Anatomy, Physiology, Organon of medicine, Pharmacy Materia Medica Pathology, Forensic Medicine and Toxicology, Surgery, Obstetrics and Gynecology,

Observation:

Commission examined the previous experience and supporting documents of Full Time teachers and Guest Lectures in various departments such as Anatomy. Physiology, Organon of medicine, Pharmacy, Materia Medica, Pathology, Forensic Medicine & Toxicology, Surgery, Obstetrics & Gynecology. The discrepancies found in experience certificate & affidavit for Dr. Yogesh Sabnis, Dept. Organon of medicine is persisting. Form 16 for these faculties were verified and recommended for an affidavit from the Principal regarding staff availability (Full Time as well as Guest Teachers) for all 09 departments

Overall observations:

The submission from SVE Trust's Veerabhadreswar Homoeopathic Medical College & Hospital, Near Sai Baba Temple. Humnabad, Dist. Bidar, Karnataka vide letter dated 06/12/2021 & 27/12/2021 have been carefully examined as per the provisions of the Homoeopathy Central Council (Minimum Standards Requirement of Homeopathic Colleges and attached Hospitals) Regulations. 2013 and the relevant regulations made there under and it is observed that the college has rectified the deficiencies pointed out by the Hearing Committee and MA&B vide letter No. 4F.No.4-7/2021-22/NCH (MA&RB))116-11)/3394 dated 29/11/2021 particularly the faculty required for the College as per MSR, 2013.

- 2 Therefore, the Commission has decided for the following:
 - Granting permission to SVE Trust's Veerabhadreswar Homoeopathic Medical College i. & Hospital, Near Sai Baba Temple, Humnabad, Dist. Bidar, Karnataka with admission capacity of 60 seats for the academic session 2021-22
 - This permission is subject to an affidavit from the Principal regarding staff availability ii. (Full Time as well as Guest Teachers) for all Departments
 - 3. Accordingly, your representation dated 06/12/2021 & 27/12/2021 to Commission against MA&RB letter dated 29/11/2021 stands disposed off.
